TO THE CONTINUING EDUCATION APPLICANT:

Please complete this application to help us determine your eligibility to receive funding which will assist you with your post-secondary education (college education or vocational training leading to the development of occupational skills or career goals). **Financial need** is our primary criteria for awarding scholarships, though academic record, community service and other special skills or talents are considered.

This application is formally complete when the remaining supporting documents (4, 5, 6 and 7) become available to you and have been received by the Advanced Standing Committee. CSFM reserves the right to process only completed applications.

Required Documents:

- 1. Completed application form (including release form). If additional space is required for any item, please attach an explanatory note referring to the questions by section. The application is a fillable PDF form. Please complete it on your computer and then print, sign and mail it to Helaine Hazlett at the address listed below.**
- 2. Cover letter describing why you believe CSFM should grant you a scholarship and explaining your academic and career plans. If you received a scholarship from us last year, indicate why you believe we should grant you a scholarship again this year.**
- 3. Cost of College or Program – a copy of 2011-2012 college or program literature which indicates a breakdown of costs (tuition, room and board, mandatory fees, etc.)**
- 4. Copy from FAFSA of the Student Aid Report (SAR) Part 1, Page 1 and the Loan Summary Page, which you will receive directly from FAFSA.**
- 5. Copy of the CSS/Financial Aid PROFILE if your college requires it.**
- 6. Transcript of your fall and spring grades.**
- 7. Copy of your financial aid award letter which you have completed and signed.**
